**Location:** Doe Mountain Recreation Area, 1203 Harbin Hill Road, Mountain City, TN, 37683

**Start Time:** 1:00 pm, Rain or Shine

**Course:** Relatively flat course along mostly machine-built trails that starts & ends at the DMRA Adventure Center. The 7.5k course has one significant hill.

**Timing:** Race will be chipped timed.

**Awards:** The top three overall female, male and veteran will receive a unique award. Top three male and female age group awards will be as follows: 14 and under, 15-19, 20-29, 30-39, 40-49, 50-59, 60-69, 70 and over.

**Entry Fee:** Veterans and Youth are just \$15.00. Adults are \$30.00. Race day registration +\$5.00
